CREDIT ADDENDA FORMAT

(CCD + Format)*

The addenda record to be created for Electronic Funds Transfer will follow the TXP Addendum Convention suggested by the Federation of Tax Administrators. An authorization agreement is required prior to initiating this payment format.

****It is important to note that ADOR's ACH Credit requirements require that the business ensure that their account is setup for CCD+ formatting. This will impact the agency's ability to successfully post your payment****

Notes and Definitions

1. (TXP01) TAXPAYER IDENTIFICATION:

Note: This ID is associated with the entity for whom the payment must apply. *This field MUST be strictly numeric. DO NOT use the alpha character or the hyphen.*

Maximum field length is TEN SPACES.

Withholding: This will be your **nine-digit** (9) Federal Identification Number.

Corporate: This will be your **nine-digit** (9) Federal Identification Number.

TPT: This will be your **eight-digit** (8) numeric Arizona TPT license number

2. (TXP02) TAX TYPE CODE:

Withholding Payments

Use "011" followed by the **sequence number**. The sequence number is an optional two-digit number indicating which payment this is for. Each **quarter** the first payment will be "01", the second payment "02," etc. The purpose of using the sequence number is to assist you in tracking your payments.

Example: The third payment for the fourth quarter would have a Tax Type Code of "01103."

Note: *If you do not wish to use the sequence number feature, please use "00" in that field.*

Corporate Estimated Payments

Use "021" for estimated payments followed by the **estimated quarter number**. This will indicate which quarter the estimated payment is to be applied. It must be a two-digit number, "01" through "04."

Example: The estimated payment for the second quarter would be "02102."

Corporate Extension Payments

Use "022" for extension payments followed by the **number 01**. This is the place holder utilized for Corporate Extension Payments.

Example: "02201"

Corporate Tax Payments

Use "023" for regular payments followed by the **number 01**. This is the place holder utilized for Corporate Tax Payments.

Example: "02301"

TPT Payments

Use "041" followed by the **TPT liability month**. This will indicate what month the TPT payment is to be applied. It must be a two-digit number, "01" through "12."

Example: The TPT payment for the liability for the month of January would be "04101."

TPT June-Only Estimated Payments

Use "042" followed by "180630" for June period end date (where 18 is the year, 06 is the month, 30 the day 6/30/2018). June is the only period where TPT estimated payments are required.

3. (TXP03) TAX PERIOD END DATE: (must be in YYMMDD format)

011 Withholding must be the **quarter end date**, not the payroll end date. Ending quarters would be "080331," "080630," "080930," or "081231." The Arizona Department of Revenue computer system uses the quarter end date to determine the quarter the payment is to be applied to. *It is the taxpayer's responsibility to specify which quarter the payment is to be applied to.*

021 Corporate must be the **fiscal year end date** for which the payment will be claimed.

041 TPT must be the **month end date** of the month of the liability that is being paid.

4. (TXP04) AMOUNT TYPE

The Amount Type is used to identify the transaction type of the amount that follows. At this time, the Department will accept tax payments only. The code for tax is "T."

5. (TXP05) AMOUNT FIELD

The Amount Field is strictly numeric with *no decimal*. This is a **ten-digit, left justified** field. Be certain to prefill with zeros. (Example: *Enter* "0000000001" to represent "\$.01")

6. (TXP06) TAXPAYER VERIFICATION

The Taxpayer Verification field is an optional field that the taxpayer may use. If this field is not used, the terminator may be placed directly after the Amount Field. Arizona does not assign a verification number.

7. (TXP07) OTHER FIELDS

Any field without a specific value or not previously referenced herein will be filled in by the vendor or bank.
