The principal is a tobacco distributor licensed by the Arizona Department of Revenue which desires to furnish a bond of surety in the amount of two times its current monthly cigarette tax stamp purchases in order to purchase cigarette tax stamps on credit pursuant to A.R.S. § 42-3459.

If the principal complies with all provisions of A.R.S. Title 42, Chapter 3, including, but not limited to payment of all taxes, penalties, and other obligations incurred by the principal and which are adjudged due and owing by the principal during the term of this bond, this obligation is void; otherwise the obligation remains in full force and effect. Pursuant to A.R.S. Title 42, the Director of the Arizona Department of Revenue may order forfeited to this State any part or all of the surety bond for nonpayment of those taxes, penalties or other obligations.

The term of this bond is continuous and regardless of the number of years it remains in force and effect, the liability of the surety shall not exceed the amount stated in this bond. This bond is effective the \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, and shall continue in force until terminated as provided in this bond. The principal or surety may terminate this bond by written notice to the Arizona Department of Revenue Tobacco Tax Unit, 1600 W Monroe, Phoenix AZ 85007. Such termination shall become effective 30 days after the actual receipt of the notice by the Department of Revenue. Termination of the bond does not affect any rights or liabilities which have accrued under this bond prior to the termination.
